Constables Report – Received the 2014 Constable Report. Humane Society contract for flat fee is \$3,000. All prices have gone up for 2015. If the Town would not have paid a flat fee in 2014 for \$1,700.00, the cost to the Humane Association for 2014 would have been \$3,800.00. Katie going to get more information from the Humane Association as to what all charges actually was. Russ needs to have all his reports filed quarterly so that we have them to compare to the Quarterly Humane Association report. Motion was made to Amend the motion from previous meeting to amend the amount to pay the Humane Association from \$2,000.00 to \$2,500.00, want quarterly reports to compare to Russ's reports. Fred Bely made the motion for this Amendment and Jeff Whyte seconded it. No one opposed, motion carries. Fred Belay will talk with Russ to let him know that we need monthly reports from him.

Convene to Closed Session – Personnel Evaluation – Fred Belay wanted to talk about doing evaluations on clerk's job. Would like to form a committee to work with on this. Fred Belay, Gloria Bloom, and Jeff Bechard will be the committee. They will meet on Tuesday January 27th at 5:00pm at Town Hall. They will make a recommendation to the Board at next Board Meeting. Will have to post this meeting at Town Hall, Fire Station, and Dana's.
