Dear Marketplace Vendor Applicant:

The Grapevine Convention & Visitors Bureau invites you to apply to participate in the 34<sup>th</sup> Annual Main Street Fest – A Craft Brew Experienceto be held May 17, 18 and 19, 2019.

Please follow all application instructions carefully and note that the deadline for submitting the application for Main Street Fest is **January 11**, **2019**. Applications postmarked by January 11, 2019 will be considered on time. Due to the volume of applicants and limited space, we are unable to accept late applications – **the deadline date is firm.** 

All applicants will be notified by letter of acceptance or non-acceptance by mail and email by February 15, 2019. Checks and photos (if applicable) are returned to applicants not selected.

- (5) Copy of Texas Sales Tax and Use Permit (photocopies are acceptable).
