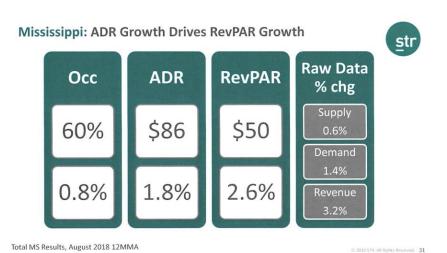

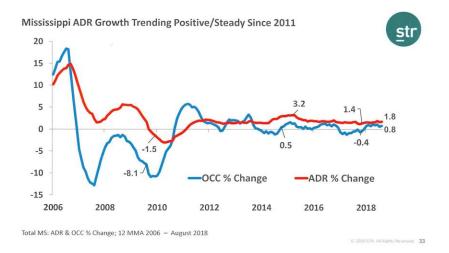

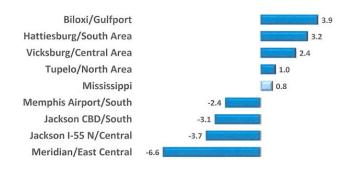






Half of Mississippi Submarkets Seeing Positive Occupancy Growth



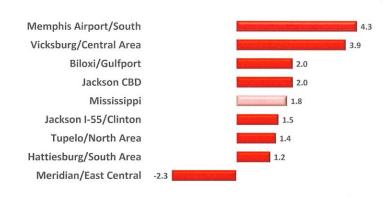

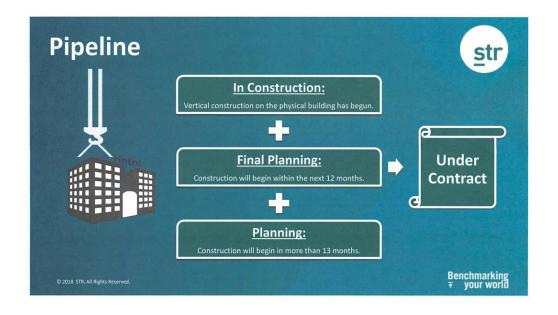

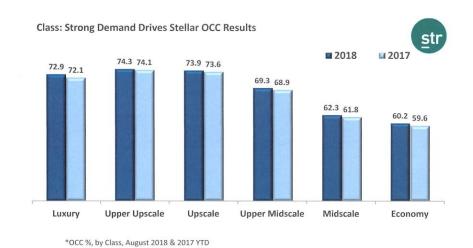

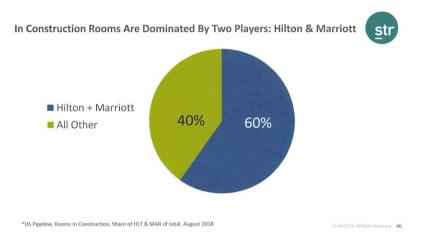


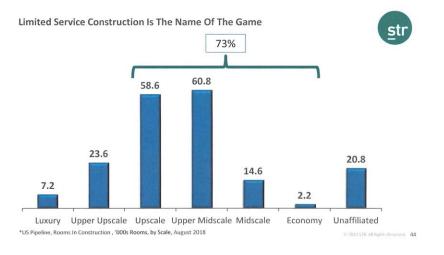
US Pipeline: Lack of In Construction Rooms Growth Aids Healthy Industry Results

*Total US Pipeline, by Phase, '000s Rooms, August 2018 and 2017



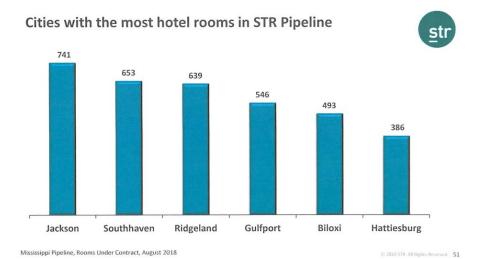
