Following a fourth record year, the region continues to engage visitors in experiencing all of what Eugene, Cascades & Coast has to offer. The result is continued growth as year-to-date room tax collections show an increase of 15 percent.

Travel Lane County estimates more than **\$24.2 Million** in spending will accrue to the local economy from our work during the period.





Room Tax Collections


