Notes & Highlights

Closing out the year with YoY gains in visitation in December, Las Vegas hosted just over 42.1 million visitors in 2018, just shy of the 42.2 million tally in 2017.

With some tradeshows rotating out of the destination during the year, most notably the triennial CONEXPO-CON/AGG tradeshow in March, Las Vegas hosted approximately 6.5 million convention attendees in 2018 (-2.2%), reaching the second highest tally on record.

Citywide occupancy in December reached 79.9%, up +2.5 pts, while ADR and RevPAR for the month reached \$119.83 (up +10.9%) and \$95.74 (up +14.5%), respectively. The 2018 annual citywide occupancy landed at 88.2% (-0.5 pts) with year-end ADR approaching \$129 (+1.2%) and RevPAR coming in at \$113.54 (+0.7%).
