

Reflecting the impacts of travel restrictions imposed in the middle of March in response to the Covid-19 pandemic, all key indicators saw dramatic YoY reductions.

Las Vegas hosted an estimated 1.5 million visitors (-58.6%) during the month as the destination was effectively empty for the second half of the month. Likewise, convention attendance saw a





Strong rates in the first half of the month showed average daily room rates (ADR) at \$143.77 (+7.3%) while Occupancy for the month averaged out at 39.8% (down -51.7 pts) which in turn translated to RevPAR of \$57.22 (down -53.3%).
