Supported by YoY increases in convention attendance and sustained Leisure visitation, Las Vegas visitor volume reached 3,475,900 in September (up +0.5%.)

Trade show rotation cycles work in the month's favor as September convention attendance exceeded 459,000 (up +4.9%) with Pack Expo (45,000 attendees) and Int'l Baking Industry Expo (23,000 attendees) rotating back into Las Vegas this year.

Citywide occupancy (88.3%) exceeded last Sep by 0.9 pts as Midweek occupancy reached 85.1%, up 1.9 pts. ADR surpassed \$137 (+0.6%) and RevPAR reached \$121 (+1.7%).
