

HOTEL SITE INFORMATION

Thank you for considering Las Vegas for your upcoming conference!

What should I bring with me?

What's the recommended duration for each hotel site tour?

Given the expansive nature of the resorts, with considerable distances between the main entrance, guest rooms, and meeting spaces, we advise allocating a minimum of 1 hour for a comprehensive tour of each hotel.

Is transportation provided during the hotel tour?

Certainly! Throughout your site tour, complimentary transportation between the scheduled properties as well as airport transfers can be arranged courtesy of either the hotels or the LVCVA. The number of allowable airport transfers may be dependent on group size and are subject to case-by-case review.

What is the recommended number of site tours in a day?

Given the size of Las Vegas hotels and the time required for hotel walkthroughs, meals, and transfers, we suggest limiting your daily itinerary to no more than 4 hotel tours per day.

Are site tours available on weekends and holidays?

Hotel site tours adhere to normal business hours, Monday to Friday, 9:00 am to 5:00 pm Pacific Time, contingent upon hotel availability. Requests for site tours during weekends and holidays are subject to case-by-case review.

Is it necessary to have a proposal from the hotels we wish to tour?

Indeed, we kindly request that you obtain a proposal from the hotel before we proceed with scheduling the site tour. We are able to support your RFP sourcing if needed.

Will the hotel provide accommodations?

Subject to hotel availability and the scale of your program, accommodations may be offered at complimentary rates or discounted site visit rates.

Will meals be provided during the site visits?

Certainly, meals during scheduled site visits will be provided by either the hotel or the LVCVA. Contingent upon the size and scope of the program.

Is airfare covered by the LVCVA or the hotel?

Generally, airfare is not covered for site visits. However, in specific instances, hotels may offer a partial credit towards airfare once the group is confirmed, contingent upon the size and scope of the program.

Do the hotels or the LVCVA provide entertainment options during the site visit?

Entertainment tickets may be offered by either the hotel or the LVCVA, depending on availability and the size and scope of the program.

Does the LVCVA provide site tours for off-site activities?

The LVCVA does not provide coordination for off-site tours, however, we are happy to make suggestions and facilitate the introductions.

How much lead time do you need?

As we get many requests for site tours, we kindly ask for at least 3-4 weeks notice to properly plan your site tour.
