

## Certificate of Insurance (COI) Requirements & Sample

- ✓ The company name provided on the application <u>must exactly match</u> the insured name on the COI. Be sure to include any Inc, LLC, Corp., etc.
- ✓ Minimum of \$1,000,000 general liability is required.
- ✓ Minimum of \$300,000 damage to rented premises is required.
- ✓ Minimum of \$1,000,000 auto liability is required. The COI must indicate either any auto <u>OR</u> hired & non-owned.
  - NOTE: Our legal department requires all EACs to provide auto liability, regardless of vehicle ownership. This is required to work in the building.
- ✓ Workers' compensation is required.
- ✓ The Las Vegas Convention and Visitors Authority (LVCVA) must be the certificate
  holder on all policies and be specifically named as additional insured for <u>BOTH</u>
  general & auto liability. The insurance agent can check the ADDL INSD boxes
  next to each policy and/or provide specific verbiage in the description of
  operations area.
  - NOTE: The legal name is Las Vegas Convention and Visitors Authority (LVCVA). Las Vegas Convention Center is not the legal name and will not be accepted.
- ✓ Since the permit is valid for one (1) calendar year, please do not reference any show name or dates of event(s) in the description of operations area.
