



1. Terms: Las Vegas Convention and Visitors Authority is seeking to promote Laughlin and Mesquite Nevada and reward businesses for participating in events in Laughlin and Mesquite and receive a food and beverage credit at a future stay. To be eligible, you must:

Attend a scheduled FAM in Laughlin or Mesquite with LVCVA Sales Executive Cherie Westbrook between the dates of April 7, 2025 through April 7, 2026.

The FAM group or meeting must be scheduled using LVCVA's online RFP system located at visitlaughlin.com and visitmesquite.com.

The group or meeting must be held at select Extended Destination resorts located within Laughlin or Mesquite.

Must fulfill 25 or more room nights and host 50 or more people.

Food and beverage credit of \$250 (the "Incentive") will be applied towards your food and beverage spend and must be redeemed during the time of booked reservation at the same ED destination resort in Laughlin or Mesquite.

Holiday, special event, and other black out dates may apply.
