13-15. #14 General Fund Balance declined by 30.7% from the previous year as a result of investment transfers in accordance with augmentation and higher expenditures.
 #15 Cash and Cash Equivalents decreased from prior year by 85.1% as a result of a different investment strategy.
 When interest rates increased, excess cash was invested rather than kept in a cash equivalent, resulting in a 118% increase in investments over that time. However, as indicated in justification #14, the total cash and investments declined by 34.8%.
