

## Terms and conditions for participation at Norway for the Culture Lovers event

*Paris, 11th October, 2022*

1. **Place:** The event will take place at Musée d'Orsay, 1 rue de la Légion d'Honneur, 75007 Paris.
2. **Date:** October 11<sup>th</sup> – from 8:30am to 4pm
3. **Norwegian participants/suppliers:** English or French language is required.  
The collaborative partner shall contribute actively to the event and give feedback on results to enable evaluation as well as document the effect of the activity. A survey will be sent after the event. The contribution also includes providing information and presentation for use before and during the activity within given deadlines.
4. **Tables:** During the event, each participant will get a table for meetings to take place. Two participants per table.
5. **Price:**  
Total price is 800 € per company  
  
Price includes in participation :
  - Up to two persons per company
  - Visibility in the product manual
  - Receive Market Manual
  - Product pitch presentation to the audience
  - One-to-one sales meetings for 2 hours
  - Breakfast and Light lunch
  - Guided visit of the Munch exhibition at Musée d'Orsay
6. **Conditions for payment:** All prices are excl. VAT. Signing up for the event is binding, even if the participant cancels participation at a later point of time.
7. **Product/Market Manual:**  
The product Manual will contain useful product information in English. The Manual will be made available for the buyers who may use it to get to know the Norwegian products. Innovation Norway claims the right to make minor adjustments in the text to make it fit the format of the manual as well as general text editing.
8. **Market Manual** supplies similar information about the buyers. Information on the buyers who have registered will be made available for the suppliers one week prior to the event.
9. **Appointment system:** No appointment system will be used for this event as it is a Niche event.
10. **Transport:** Transport to/from Paris must be booked and paid for by the participants themselves. In addition, local transfers in Paris will not be included
11. **Accommodation:** Accommodation in Paris must be booked and paid for by the participants themselves.

- 12. Material:** Participants themselves will cover potential costs for sending material to the venue. They are also themselves responsible for having any necessary insurance to cover such material.
- 13. General:** Participants may not organise or arrange other events or gatherings for the buyers parallel to the event.
- 14. Participation:** Innovation Norway claims the right to check credit score of participating companies and claims the right to deny participation if the score is low. Innovation Norway may deny participation at the event if the company does not meet its economic obligations towards Innovation Norway.
- 15. Cancellation of the event:** Innovation Norway claims the right to cancel / postpone the event at the latest 14 days prior the event if the number of registrations from invited French operators is below 10. In such situation, Innovation will only refund the participation fee.
- 16. Force majeure:** Circumstances outside the control of Innovation Norway, such as strikes, official and unofficial disruptions of work/labour disputes, fires, wars, natural catastrophes, deficient sub-supplies etc. entitles Innovation Norway to terminate the agreement without any obligation of compensation
