#### ► COMMISSIONER COMMENTS

- Connie Born said Stephanie Oswald of WGNO's News With A Twist came to the East Chamber Marketplace last month, spent an entire day in her studio. What was supposed to be a segment lasting a couple of minutes turned in to four segments.
- Sharon Lo Drucker said downtown Covington is trying to revamp and reenergize its Mardi Gras Day celebration. Lieutenant Governor Nungesser is going to be the Grand Marshal.
- Susan Nuss said people can subscribe to the Southern Hotel's newsletter for information about events at the hotel that are open to the public as well as events happening in Covington.
- Mark Myers said that he would like to extend an invitation to the Northshore Regional Partnership Board (NRPB) to attend one of our meetings. We provided them with answers to a written request and Donna, along with consultant Judy Randall, met with the NRPB board on January 23, presenting them with further information. An additional request was hand-delivered this morning asking for more data as well as our rationales for the decisions we have made. He said the NRPB does not hold public meetings and invited them to address us in this forum so we can inquire who are you and who has charged you with reviewing us and what is your due diligence process so we know that we are supporting you and you are supporting us. Following discussion, an invitation to the NRPB will be issued for a special board meeting for which the date and location is to be decided.

They have a beer fest, with home brewers coming up and it is an event that is trying to build. They have a home show and a baseball tournament with a record number of teams participating.

She attended a police jury convention event last week and Billy Nungesser was there and she asked him for every dollar that is invested how much do we get back and his answer was \$38. She said it is a reminder of how important the work we are doing is and congratulated the Tourist Commission on a job well done.
